BY-LAW No. 20-2015

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Albany Avenue, Arlington Avenue, Bank Street, Berkshire Avenue, Cavell Avenue, Cedarvale Avenue, Clinton Street, Curzon Street, Fairmount Crescent, Hammersmith Avenue, Herbert Avenue, Kenilworth Avenue, Kewbeach Avenue, Lappin Avenue, Lindsey Avenue, Mitchell Avenue, Norwood Terrace, Palmerston Avenue, Pape Avenue, Perth Avenue, Roxborough Street West, Sorauren Avenue, Wellington Street West and Wells Street.
