BY-LAW No. 28-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Tecumseth Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Tecumseth Street	West	Wellington Street West and Tecumseth Plane (north intersection)	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Tecumseth Street	West	Wellington Street West and King Street West	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Tecumseth Street	East	King Street West and a point 30 metres south	Anytime
Tecumseth Street	West	King Street West and Tecumseth Place (north intersection)	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Tecumseth Street	East	Wellington Street West and a point 82 metres south of King Street West	10:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Tecumseth Street	East	Wellington Street West and King Street West	10:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour

F. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Tecumseth Street	East	A point 30 metres south of King Street West and a point 52 metres further south	7:00 a.m. to 7:00 p.m., Mon. to Fri.
