BY-LAW No. 82-2015

To repeal provisions in former City of Toronto Municipal Code Chapter 400, Traffic and Parking, former City of Toronto Municipal Code Chapter 313, Streets and Sidewalks and to repeal former City of Toronto Municipal Code Chapter 248, Parking Licences, and former Borough of East York By-law No. 122-93.

Whereas City Council on June 27, 28 and 29, 2006 recommended that, at such time as the General Manager, Transportation Services, and the City Solicitor deem appropriate, the existing provisions in the Code Chapters and by-laws, or relevant sections thereof, of the former municipalities as set out in Recommendation (A)(3) of Consolidated Clause in Planning and Transportation Committee and Works Committee Joint Report 1, and any other provisions that may be identified by the General Manager or City Solicitor, that relate to and have been superseded or replaced by the new Code Chapter, be rescinded; and

Whereas City Council on June 27, 28 and 29, 2006 recommended that the City Solicitor be given the authority to amend any City By-laws or Code Chapters, or sections therein, which may contain reference to any by-law or Code Chapter, or section therein, which is to be superseded by the proposed Chapter 918 to eliminate and, where appropriate, correct such references; and

Whereas By-law No. 680-2006, being a by-law "To adopt a new City of Toronto Municipal Code Chapter 918, Parking on Residential Front Yards and Boulevards", was enacted by City of Toronto Council on July 27, 2006;

The Council of the City of Toronto enacts:

- 1. Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code is amended by:
 - A. Amending Subsection 400-3A by deleting the phrase: "Subject to §§ 400-9D and E, 400-10, 400-34, 400-47, 400-48" and inserting in lieu thereof the phrase: "Subject to §§ 400-10, 400-34".
 - B. Repealing Subsections 400-2B(6), 400-2B(7), 400-2B(8), 400-9D, 400-9E and Sections 400-46, 400-47, 400-48 and 400-49.
- **2.** Chapter 313, Streets and Sidewalks, of the former City of Toronto Municipal Code is amended by repealing Section 313-39.
- **3.** Chapter 248, Parking Licences, of the former City of Toronto Municipal Code is repealed.

4. Former Borough of East York By-law No. 122-93, being a by-law "To licence and regulate boulevard parking in residential areas", is repealed.
