CITY OF TORONTO

BY-LAW No. 439-2015

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Berkshire Avenue, Carlaw Avenue, Cedarvale Avenue, Crawford Street, Dundas Street East, Glebeholme Boulevard, Grenadier Road, Lee Avenue, Lisgar Street, Logan Avenue, Milverton Boulevard, Monarch Park Avenue, Mountalan Avenue, Sparkhall Avenue and Victor Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Crawford Street	East	A point 76.9 metres south of Bloor Street West and a point 6 metres further south	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1 st day to the 15 th day of each month from Apr. 1 to Nov. 30, inclusive
Crawford Street	West	A point 76.9 metres south of Bloor Street West and a point 6.6 metres further south	Anytime from the 16 th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Dundas Street East	South	A point 121 metres east of Coxwell Avenue and a point 5.5 metres further east	Anytime
Victor Avenue	Both	A point 294 metres east of Broadview Avenue and a point 5.5 metres further east	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Berkshire Avenue	East	A point 68.5 metres south of Queen Street East and a point 5.5 metres further south	Anytime
Carlaw Avenue	East	A point 22 metres north of Frizzell Avenue and a point 5.5 metres further north	Anytime
Cedarvale Avenue	West	A point 86 metres south of Danforth Avenue and a point 5.5 metres further south	Anytime
Glebeholme Boulevard	North	A point 94 metres west of Woodbine Avenue and a point 5.5 metres further west	Anytime
Grenadier Road	South	A point 119.2 metres east of Roncesvalles Avenue and a point 5.5 metres further east	Anytime
Lee Avenue	West	A point 100 metres south of Williamson Road and a point 5.5 metres further south	Anytime
Lisgar Street	East	A point 49.3 metres north of Queen Street West and a point 5.5 metres further north	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Lisgar Street	West	A point 48.5 metres north of Queen Street West and a point 5.5 metres further north	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive

Logan Avenue	East	A point 98 metres south of Browning Avenue and a point 5.5 metres further south	Anytime
Milverton Boulevard	North	A point 16 metres east of Wiley Avenue and a point 5.5 metres further east	Anytime
Monarch Park Avenue	East	A point 92.5 metres north of Felstead Avenue and a point 5.5 metres further north	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive.
Monarch Park Avenue	West	A point 91 metres north of Felstead Avenue and a point 5.5 metres further north	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Mountalan Avenue	North	A point 84.5 metres east of Greenwood Avenue and a point 5.5 metres further east	Anytime
Sparkhall Avenue	South	A point 56.5 metres west of Ingham Avenue and a point 5.5 metres further west	Anytime
