

**CITY OF TORONTO**

**BY-LAW No. 446-2015**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking,  
respecting Balsam Avenue.**

Whereas former City of Toronto Council, at its meeting held on July 5, 1996, adopted City Services Committee Report 9, Clause 8, entitled "Prohibition of stopping at anytime - Balsam Avenue, both sides, in the vicinity of Kingston Road (Ward 10)" and, in so doing, replaced the parking prohibition in effect at all times on west side of Balsam Avenue, from Queen Street East to Kingston Road, with a stopping prohibition in effect at all times on the west side of Balsam Avenue, from Kingston Road to a point 50 metres south, and a parking prohibition in effect at all times on the west side of Balsam Avenue, from Queen Street East to a point 50 metres south of Kingston Road; and

Whereas the former City of Toronto Council, at its meeting of July 5, 1996 enacted By-law No. 1996-0352 in connection with the above-noted Clause and, in so doing, enacted "No Stopping Anytime" on the west side of Balsam Avenue, from Kingston Road to a point 50 metres south; and

Whereas By-law No. 1996-0352 should also have re-enacted "No Parking Anytime" on the west side of Balsam Avenue, from Queen Street East to a point 50 metres east of Kingston Road, but did not; and

Whereas the above-mentioned error/oversight was carried over in Schedule XXIII, No Parking Certain Times, to former City of Toronto Municipal Code Chapter 400, Traffic and Parking, when former City of Toronto traffic and parking By-laws were codified in 1996, and in Schedule XIII, No Parking, to Municipal Code Chapter 950, Traffic and Parking, when the consolidated traffic and parking Code Chapter was enacted under By-law No. 1409-2011 on December 1, 2011; and

Whereas the west side of Balsam Avenue, between Queen Street East and a point 50 metres south of Kingston Road, has been signed since 1996 and continues to be signed as "No Parking Anytime", in accordance with Recommendation 1 of City Services Committee Report 9, Clause 8, as adopted by the former City of Toronto Council on July 5, 1996; and

Whereas under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

- A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Balsam Avenue	West	Queen Street East and a point 50 metres south of Kingston Road	Anytime
