CITY OF TORONTO

BY-LAW No. 570-2015

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Adelaide Street West, Cowan Avenue, Euclid Avenue, High Park Boulevard, Indian Road Crescent, Laxton Avenue, Palmerston Avenue, Sarnia Avenue, Triller Avenue and Wells Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Cowan Avenue	West	A point 65.2 metres north of Springhurst Avenue and a point 5.5 metres further north	Anytime
Euclid Avenue	East	A point 166.7 metres south of College Street and a point 6.3 metres further south	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Euclid Avenue	West	A point 166 metres south of College Street and a point 6.1 metres further south	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Laxton Avenue	South	A point 64.1 metres east of Dowling Avenue and a point 5.5 metres further east	Anytime
Wells Street	South	A point 46 metres west of Kendal Avenue and a point 5.5 metres further west	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Adelaide Street West	North	A point 15 metres east of Walnut Avenue and a point 6 metres further east	Anytime
Cowan Avenue	West	A point 63.1 metres north of Springhurst Avenue and a point 5.5 metres further north	Anytime
Euclid Avenue	East	A point 15 metres south of Dundas Street West and a point 5.5 metres further south	Anytime
High Park Boulevard	South	A point 9 metres west of Sunnyside Avenue and a point 5.5 metres further west	Anytime
Indian Road Crescent	West	A point 12.3 metres south of Annette Street and a point 5 metres further south	Anytime
Palmerston Avenue	East	A point 169.5 metres north of Dundas Street West and a point 5.5 metres further north	Anytime from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Palmerston Avenue	West	A point 169.5 metres north of Dundas Street West and a point 5.5 metres further north	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive and from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Sarnia Avenue	North	A point 84.7 metres east of Campbell Avenue and a point 5.5 metres further east	Anytime

Triller Avenue	West	A point 35.8 metres north of King Street West and a point 5.5 metres further north	Anytime
