## **CITY OF TORONTO**

## BY-LAW No. 603-2015

To amend City of Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties and Chapter 844, Waste Collection, Residential Properties, to adjust the hours for the Daytime Collection Period and the Night-Time Collection Period.

Whereas under Section 841-21A of City of Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties and under Section 844-27A of City of Toronto Municipal Code Chapter 844, Waste Collection, Residential Properties, Council has authorized the General Manager of Solid Waste Management Services, among other things, to "determine the frequency and scheduling of the services to be provided under this chapter"; and

Whereas under Section 841-21K of City of Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties and under Section 844-27I of City of Toronto Municipal Code Chapter 844, Waste Collection, Residential Properties, Council has authorized the General Manager of Solid Waste Management Services to "establish such other things as are necessary for the proper administration of this chapter"; and

Whereas under Section 169-26A of Municipal Code Chapter 169, Officials, City, the City Solicitor "may process by-laws where an action is authorized by Council and if the recommendation to amend a by-law or introduce a bill has been omitted"; and

Whereas the General Manager of Solid Waste Management Services now has determined that the hours for daytime collection under Chapter 841 and Chapter 844 can conclude one hour later, that the hours for night-time collection under Chapter 841 can commence two hours earlier; and that the hours for night-time collection under Chapter 844 should be adjusted to align with Chapter 841; and

Whereas the recommendation to introduce a bill to amend Chapter 841 and Chapter 844 to implement these changes has been omitted;

The Council of the City of Toronto enacts:

- **1.** Section 841-1 of Chapter 841, Waste Collection, Commercial Properties, is amended as follows:
  - A. By replacing "5:00 p.m." with "6:00 p.m." in the definition of DAYTIME COLLECTION PERIOD.
  - B. By replacing "11:00 p.m." with "9:00 p.m." in the definition of NIGHT-TIME COLLECTION PERIOD.

- **2.** Section 844-1 of Chapter 844, Waste Collection, Residential Properties, is amended as follows:
  - A. By replacing "5:00 p.m." with "6:00 p.m." in the definition of DAYTIME COLLECTION PERIOD.
  - B. By replacing "8:00 p.m." with "9:00 p.m." in the definition of NIGHT-TIME COLLECTION PERIOD.
- **3.** This by-law comes into force upon enactment.
