

CITY OF TORONTO

BY-LAW No. 648-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, as amended by By-law No. 522-2015, respecting temporary amendments to traffic and parking regulations on various streets required in connection with the 2015 Pan Am/Parapan Am Games.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Queens Quay West	Both	A point 18 metres east of Bay Street and a point 27 metres further east	Anytime from July 1, 2015 to July 28, 2015, inclusive (Games Client Vehicles only)

B. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Bremner Boulevard	North	York Street and Lower Simcoe Street	Anytime from June 30, 2015 to July 28, 2015, inclusive (Games Client Vehicles only)
Cooper Street	Both	Queens Quay West and a point 60 metres north	6:00 a.m. to midnight from July 1, 2015 to July 28, 2015, inclusive (Games Client Vehicles only)
Hoskin Avenue	North	Devonshire Place and St. George Street	Anytime from July 8, 2015 to August 16, 2015, inclusive (Games Client Vehicles only)
Queens Quay West	South	A point 18 metres east of Bay Street and Yonge Street	Anytime from July 1, 2015 to July 28, 2015, inclusive (Games Client Vehicles only)

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Queens Quay West	South	Yonge Street and Freeland Street	6:00 a.m. to 11:00 a.m. from July 11, 2015 to July 26, 2015, inclusive (Games Client Vehicles only)

- C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Cherry Street	Both	Ship Channel Bridge and Lake Shore Boulevard East	Anytime from June 29, 2015 to August 20, 2015, inclusive
Commissioners Street	Both	Cherry Street and Munitions Road	Anytime from June 29, 2015 to August 20, 2015, inclusive
Military Trail	Both	Neilson Road and Conlins Road	Anytime from June 29, 2015 to August 18, 2015, inclusive

- D. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Hoskin Avenue	St. George Street and Devonshire Place	Anytime from July 8, 2015 to August 16, 2015, inclusive	Eastbound

- E. By deleting from Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(From Column 1 Intersection or Portion of Highway)	(From Column 2 Direction)	(From Column 3 Turns Prohibited)	(From Column 4 Times and/or Days)
Carlton Street and Yonge Street	Eastbound and Westbound	Left	5:00 a.m. to 11:00 p.m. from June 29, 2015 to August 18, 2015, inclusive

F. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Carlton Street and Yonge Street	Eastbound	Left (TTC Vehicles Excepted)	5:00 a.m. to 11:00 p.m. from June 29, 2015 to August 18, 2015, inclusive
Carlton Street and Yonge Street	Westbound	Left	5:00 a.m. to 11:00 p.m. from June 29, 2015 to August 18, 2015, inclusive

G. By amending Subsection (3) in § 950-1202A by inserting the phrase: ", with the exception of By-law No. 648-2015," after the phrase: "contrary in any other by-law" and after the phrase: "conflicts with any other regulation".

H. By inserting a new Subsection (4) in § 950-1202A as follows:

"(4) During the time frame indicated in the entry in Subsection 1A to 1F, inclusive, of By-law No. 648-2015, and despite § 950-1202A(3), the provisions of Subsections 1A to 1F of By-law No. 648-2015 shall apply notwithstanding anything to the contrary in any other by-law or chapter of the Municipal Code. For further clarity, where any regulation contained in Subsection 1A to 1F, inclusive, of By-law No. 648-2015 conflicts with any other regulation in any Schedule of Municipal Code Chapter 950, Traffic and Parking, or in By-law No. 522-2015, the regulation as found in By-law No. 648-2015 shall prevail during the time frame outlined in the regulation as found in By-law No. 648-2015."
