**CITY OF TORONTO**

**BY-LAW No. 658-2015**

**To authorize the naming of a proposed public street, located at 2143 to 2183 Lake Shore Boulevard West and 80 Marine Drive, as "Annie Craig Drive".**

Whereas pursuant to § 27-152E(5) of City of Toronto Municipal Code Chapter 27, Council Procedures, Etobicoke York Community Council has the authority to pass a by-law naming the proposed public street;

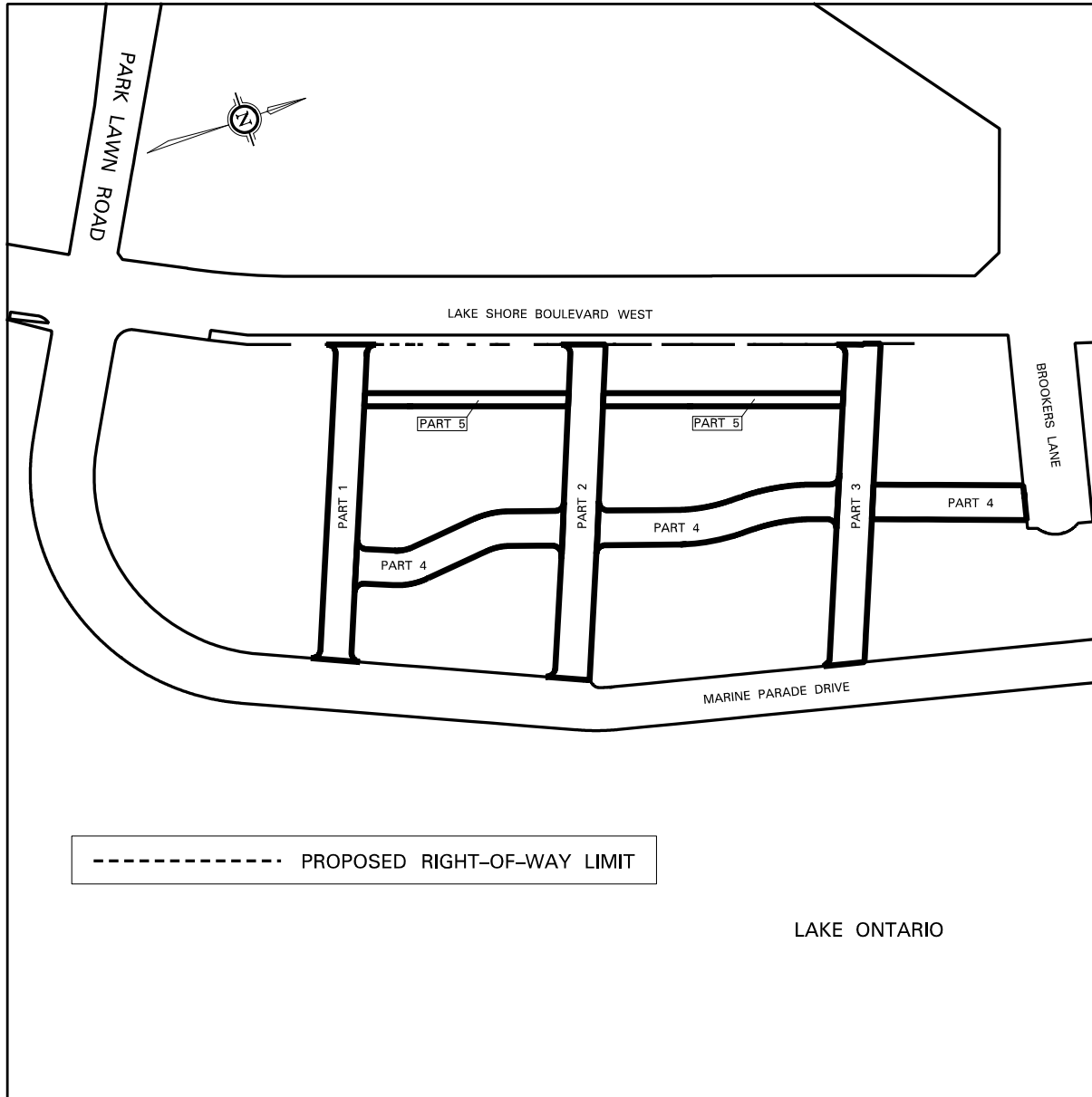
