## **CITY OF TORONTO**

### **BY-LAW No. 747-2015**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dufferin Street, Jameson Avenue, Springhurst Avenue and Tyndall Avenue.**

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Dufferin Street	West	Thorburn Avenue and a point 29 metres south of King Street West	25	Anytime from and including Fri. Aug. 21, 2015 to and including Mon. Sept. 7, 2015

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
