BY-LAW No. 831-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting temporary amendments to traffic and parking regulations on Mill Street and Trinity Street, required in connection with the 2015 Pan Am/Parapan Am Games.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Number of Taxicabs)	(From Column 5 Times and/or Days)
Mill Street (TO)	North	Between Trinity Street and a point 50 metres west	10	Anytime from July 10, 2015 to Aug. 18, 2015, inclusive

B. By inserting in Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Number of Taxicabs)	(In Column 5 Times and/or Days)
Trinity Street	West	Between Mill Street and Front Street East	18	Anytime

C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mill Street (TO)	South	Parliament Street and Trinity Street	Anytime

D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mill Street (TO)	North	Trinity Street and a point 50 metres west	Anytime from July 10, 2015 to Aug. 18, 2015, inclusive
Mill Street (TO)	South	Parliament Street and Trinity Street	Anytime from July 10, 2015 to Aug. 18, 2015, inclusive

E. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Mill Street (TO)	Trinity Street and Parliament Street	Anytime from July 10, 2015 to Aug. 18, 2015, inclusive	Westbound
Trinity Street	Front Street East and Mill Street	Anytime from July 10, 2015 to Aug. 18, 2015, inclusive	Southbound

2. This By-law shall be effective commencing August 19, 2015.
