CITY OF TORONTO

BY-LAW No. 973-2015

To amend City of Toronto Municipal Code Chapter 545, Licensing, to delete obsolete classes and definitions and to include various amendments.

Whereas under sections 7 and 8 of the *City of Toronto Act, 2006* (the "Act"), the City may pass by-laws in respect of the health, safety and well-being of persons and the economic, social and environmental well-being of the City; and

Whereas the Act grants the City of Toronto the authority to enact by-laws for the licensing, regulating and governing of businesses wholly or partly carried on in the City of Toronto, including the ability to require the payment of fees; and

Whereas notice of the intention to enact this by-law has been provided in accordance with the Act and its regulations;

The Council of the City of Toronto enacts:

1. Section 545-1 of Municipal Code Chapter 545, Licensing, is amended by deleting the following definitions in alphabetical order:

"ACUPUNCTURE and/or TRADITIONAL MEDICINE" "COMMISSIONER" "ELECTRICAL CONTRACTOR" "ELECTRICAL WORK" "MASTER ELECTRICIAN" "SPECIAL SALE" "TRADITIONAL MEDICINE" "TRADITIONAL MEDICINE ESTABLISHMENT" "TRADITIONAL MEDICINE PRACTITIONER" "TRAILER" "TRAILER"

- 2. Section 545-4D of Municipal Code Chapter 545, Licensing, is amended by deleting the words "the Commissioner,".
- **3.** Sections 545.5B, 545-30B(7), 545-32B, 545-173B, 545-258, 545-303 and 545-358 of Municipal Code Chapter 545, Licensing, are amended by deleting the word "Commissioner" and replacing it with the words "Executive Director".
- 4. The definition of "Executive Director" in § 545-1 of Municipal Code Chapter 545, Licensing, is amended by deleting the words "of the Urban Development Services Department".

- 5. The definition of "Municipal Licensing and Standards Division" in § 545-1 of Municipal Code Chapter 545, Licensing, is amended by deleting the words "of the Urban Development Services Department".
- 6. The definition of "Public Garage" in § 545-1 of Municipal Code Chapter 545, Licensing, is amended by deleting the words "and an automobile service station other than as described in 545-2A(40) of this chapter ".
- 7. Municipal Code Chapter 545, Licensing, is amended by deleting Article XXIX, Distribution of Bills, and § 545-2A(5).
- 8. Municipal Code Chapter 545, Licensing is amended by deleting § 545-2A(14).
- **9.** Municipal Code Chapter 545, Licensing, is amended by deleting Article XIX, Sale of Horse Meat and Fresh Meat and §§ 545-2A(22) and 545-2A(23).
- **10.** Municipal Code Chapter 545, Licensing, is amended by deleting § 545-2A(25).
- **11.** Municipal Code Chapter 545, Licensing, is amended by deleting § 545-2A(32).
- **12.** Municipal Code Chapter 545, Licensing, is amended by deleting from Article XXII, Public Garages all references to "Automobile Service Station" and by deleting § 545-2A(40).
- **13.** Municipal Code Chapter 545, Licensing, is amended by deleting Article V, Owners and Drivers of Horse-Drawn Vehicles Used or Kept for Hire for the Purpose of Providing Sightseeing Tours, § 545-2A(41) and Appendix B, Areas where Horse Drawn Vehicles are Prohibited.
- **14.** Municipal Code Chapter 545, Licensing, is amended by deleting Article XXVI, Swimming Pools and Public Bath Premises Operated for Profit and § 545-2A(43).
- **15.** Municipal Code Chapter 545, Licensing, is amended by deleting Article XXVII, Owners and Keepers of Trailer Camps and §§ 545-2A(46) and 545-2A(48).
- 16. Municipal Code Chapter 545, Licensing, is amended by deleting Article XXVIII, Special Sales, § 545-2A(54), Appendix G, Statutory Declaration of Applicant for Special Sales Licence and Appendix H, Extension of Special Sales Licence.
- 17. Municipal Code Chapter 545, Licensing, is amended by adding § 545-4B(5), which reads "The Executive Director may issue and renew licences on a multi-year basis and require the payment of corresponding multi-year licensing fees.".
- **18.** Section 545-4D of Municipal Code Chapter 545, Licensing, is amended by deleting the first reference to "this chapter" and replacing it with the words "Chapter 441, Fees and Charges".

- **19.** Section 545-4G(3) of Municipal Code Chapter 545, Licensing, is amended by deleting the words "Effective July 1, 2004" and "(the "new renewal date"), provided that the applicable licence fees for renewal in 2005 shall be phased-in on a pro-rated basis as follows:" and by adding the words "or any other harmonized renewal date determined by this section. Where a licensee has been issued more than one licence the Executive Director may allow for the harmonization of renewal dates and payment of corresponding licensing fees.".
- **20.** Municipal Code Chapter 545, Licensing is amended by deleting 545-4G(3)(a) and 545-4G(3)(b).
- **21.** Section 545-4G(4) of Municipal Code Chapter 545, Licensing, is amended by deleting the words "Effective January 1, 2005" and "as follows".
- 22. Municipal Code Chapter 545, Licensing is amended by deleting \$ 545-4G(4)(a), 545-4G(4)(b) and 545-4G(4)(c).
- **23.** Section 545-4G(5) of Municipal Code Chapter 545, Licensing, is amended by deleting the words "Effective January 1, 2005".
- 24. Section 545-4L of Municipal Code Chapter 545, Licensing, is amended by deleting the words "Appendix A at the end of this chapter" and replacing them with the words "Chapter 441, Fees and Charges" and by deleting the words "shall be from the period commencing on the date of issuance or renewal of such licences and, unless they are sooner forfeited or revoked, shall, in each case, expire in each year on the date as set out in" and replacing them with the words "shall be valid from the date of their issuance or renewal and, unless previously forfeited or revoked, shall expire on the date determined as per".
- 25. Municipal Code Chapter 545, Licensing is amended by deleting § 545-4M.
- 26. Municipal Code Chapter 545, Licensing is amended by deleting § 545-4N.
- 27. Section 545-4O of Municipal Code Chapter 545, Licensing, is amended by deleting the words "Effective July 1, 2004," and "of \$54.00".
- **28.** Municipal Code Chapter 545, Licensing, is amended by deleting §§ 545-5G(7) and 545-5G(8).
- **29.** Municipal Code Chapter 545, Licensing, is amended by moving §§ 545-5F, 545-5G and 545-5H to Article X, renumbering these as §§ 545-157D, 545-157E and 545-157F respectively and revising all references in Chapter 545, Licensing, to §§ 545-5F, 545-5G and 545-5H accordingly.
- **30.** Municipal Code Chapter 545, Licensing, Appendix A is deleted.
- **31.** Municipal Code Chapter 545, Licensing, Appendix K, Business Licensing Thresholds is amended by adding § 2-J under the heading "Group No. 2" which reads: "When

calculating by-law demerit point totals under 2-A for licences which stipulate a business location, such demerit points will only apply to the licence for the location or locations where the by-law offence or offences occurred."
