## **CITY OF TORONTO**

### **BY-LAW No. 1098-2015**

#### **To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Berkshire Avenue, Glebeholme Boulevard, Jersey Avenue, Northcote Avenue and Paton Road.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| Berkshire Avenue              | East                       | A point 68.5 metres south of Queen Street East and a point 5.5 metres further south | Anytime                            |
| Glebeholme Boulevard          | North                      | A point 94 metres west of Woodbine Avenue and a point 5.5 metres further west       | Anytime                            |

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

|-----------------------------|--------------------------|---|---|
| Jersey Avenue               | East                     | A point 105 metres north of Harbord Street and a point 6.1 metres further north     | Anytime   |
| Northcote Avenue            | East                     | A point 66.2 metres north of Queen Street West and a point 5.5 metres further north | Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month, from Apr. 1 to Nov. 30, inclusive |

|-----------------------------|--------------------------|--|--|
| Northcote Avenue            | West                     | A point 66.5 metres<br>north of Queen Street<br>West and a point<br>5.5 metres further north | Anytime from the 16th day to<br>the last day of each month, from<br>Apr. 1 to Nov. 30, inclusive |
| Paton Road                  | South                    | A point 60.5 metres<br>west of Lansdowne<br>Avenue and a point<br>5.5 metres further west    | Anytime  |
