CITY OF TORONTO

BY-LAW No. 1204-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Agate Road, Downsview Avenue, Ianhall Road, Julian Road, Pleasant Home Boulevard, Ridge Road, Roding Street, Victory Drive and Wintergreen Road.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

| Julian Road | East | Wilson Avenue and Victory Drive | 2:00 a.m. to 6:00 a.m. |
| Pleasant Home Boulevard | East | A point 15 metres north of Wilson Avenue and Victory Drive | 9:00 a.m. to 4:00 p.m., Mon. to Fri. |
| Pleasant Home Boulevard | West | Wilson Avenue and Victory Drive | Anytime |
| Ridge Road | West | Wilson Avenue and a point 107 metres south | Anytime |
| Victory Drive | Both | Ianhall Road and Agate Road | 8:00 a.m. to 4:00 p.m., Mon. to Fri. |
| Wintergreen Road | South | Victory Drive and a point 25 metres east of Ianhall Road | 8:00 a.m. to 4:00 p.m., Mon. to Fri. |

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:
