

Authority: Item TE12.53, as adopted by Toronto and East York Community Council on November 10, 2015 under the delegated authority of Sections 27-149B and 27-152 of City of Toronto Municipal Code Chapter 27, Council Procedures

CITY OF TORONTO

BY-LAW No. 1236-2015

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Adelaide Street West, Dovercourt Road, Eastwood Road, Empire Avenue, First Avenue, Jersey Avenue, Logan Avenue, Oakcrest Avenue, Paton Road and Roseheath Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:

A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Jersey Avenue	East	A point 90 metres north of Harbord Street and a point 5.5 metres further north	Anytime
Logan Avenue	East	A point 98 metres south of Browning Avenue and a point 5.5 metres further south	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Adelaide Street West	North	A point 87 metres west of Tecumseth Street and a point 5.5 metres further west	Anytime
Dovercourt Road	West	A point 124.7 metres south of Dundas Street West and a point 5.5 metres further south	Anytime
Eastwood Road	South	A point 45 metres west of Bowmore Road and a point 5.5 metres further west	Anytime

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Empire Avenue	East	A point 106.5 metres north of Eastern Avenue and a point 5.5 metres further north	Anytime
First Avenue	South	A point 9 metres east of Logan Avenue and a point 5.5 metres further east	Anytime
Oakcrest Avenue	North	A point 54 metres east of Morton Road and a point 5.5 metres further east	Anytime
Paton Road	North	A point 11.8 metres east of Symington Avenue and a point 5.5 metres further east	Anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1st day to the 15th day of each month from Apr. 1 to Nov. 30, inclusive
Paton Road	South	A point 21.5 metres east of Symington Avenue and a point 5.5 metres further east	Anytime from the 16th day to the last day of each month from Apr. 1 to Nov. 30, inclusive
Roseheath Avenue	West	A point 22 metres north of Murdock Avenue and a point 5.5 metres further north	Anytime
