BY-LAW No. 1248-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Redpath Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Redpath Avenue	East	A point 120.4 metres north of Soudan Avenue and Eglinton Avenue East	7:00 a.m. to 9:00 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Redpath Avenue	East	Soudan and a point 55 metres north	7:00 a.m. to 9:00 a.m., 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Redpath Avenue	West	A point 120.4 metres north of Soudan Avenue and the north end of Redpath Avenue	Anytime
Redpath Avenue	West	Manor Road East and a point 55 metres north of Soudan Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Redpath Avenue	East	Eglinton Avenue East and Soudan Avenue	7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Redpath Avenue	West	Manor Road East and the north end of Redpath Avenue	Anytime

C. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Redpath Avenue	Both	A point 55 metres north of Soudan Avenue and a point 65.4 metres further north	Anytime
