CITY OF TORONTO

BY-LAW No. 1259-2015

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Crawford Street, Douro Street and Euclid Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Crawford Street	East	A point 10.3 metres south of Shank Street and a point 11 metres further south	Anytime (car-share vehicles excepted)
Douro Street	Both	King Street West and Strachan Avenue	Anytime
Euclid Avenue	East	Dundas Street West and a point 19.2 metres south	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Douro Street	North	A point 12 metres east of Shaw Street and a point 11 metres further east	Anytime (car-share vehicles excepted)
Douro Street	North	A point 23 metres east of Shaw Street and Strachan Avenue	Anytime
Douro Street	North	King Street West and a point 12 metres east of Shaw Street	Anytime

Crawford Street	West	King Street West and Adelaide Street West	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour
Euclid Avenue	East	Queen Street West and a point 30.2 metres south of Dundas Street West	8:00 a.m. to 6:00 p.m.	1 hour

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Crawford Street	Both	King Street West and Adelaide Street West	8:00 a.m. to 6:00 p.m., Mon. to Fri.	1 hour
Euclid Avenue	East	Queen Street West and Dundas Street West	8:00 a.m. to 6:00 p.m.	1 hour

E. By deleting from Schedule XLIII (Car-Share Vehicle Parking Areas) in § 950-1342, the following in alphabetical order by street name:

Crawford Street	East	A point 10.3 metres south of Shank Street and a point 11 metres further south	2	Zipcar
Euclid Avenue	East	A point 19.2 metres south of Dundas Street West and a point 11 metres further south	Up to 3	Car2Go

Douro Street	North	A point 12 metres east of Shaw Street and a point 11 metres further east	Up to 3	Car2Go
