**CITY OF TORONTO**

**BY-LAW No. 364-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bayview Avenue, Front Street East and Lawren Harris Square.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By inserting in Schedule XIX (One-Way Traffic Lanes) in § 950-1318, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Lanes)	(In Column 4 Time and/or Days)	(In Column 5 Direction)
Bayview Avenue and Front Street East	Front Street East and a point 80 metres north	Westerly Southbound	Anytime	Southbound right-turning
Bayview Avenue and Lawren Harris Square (north leg)	Lawren Harris Square (north leg) and a point 70 metres west of Front Street East	Southerly Eastbound	Anytime	Eastbound left-turning
Bayview Avenue and Lawren Harris Square (south leg)	Lawren Harris Square (south leg) and a point 70 metres west of Front Street East	Southerly Eastbound	Anytime	Eastbound right-turning

- B. By inserting in Schedule XXIII (Prohibited Turns) in § 950-1322, the following in alphabetical order by street name:

(In Column 1 Intersection or Portion of Highway)	(In Column 2 Direction)	(In Column 3 Turns Prohibited)	(In Column 4 Times and/or Days)
Bayview Avenue and Lawren Harris Square (north leg)	North	Left	Anytime
Bayview Avenue and Lawren Harris Square (south leg)	East	Left	Anytime
Bayview Avenue and Lawren Harris Square (south leg)	South	Right	Anytime (bicycles)

Bayview Avenue (northbound)	Lawren Harris Square (north leg)	Bayview Avenue (southbound)
Bayview Avenue (southbound)	Lawren Harris Square (south leg)	Bayview Avenue (northbound)

D. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Bayview Avenue and Front Street East	Bayview Avenue
Bayview Avenue and Lawren Harris Square (north leg)	Bayview Avenue (northbound)
