**CITY OF TORONTO**

**BY-LAW No. 478-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Basil Hall Court.**

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
- A. By deleting from Schedule IV (Former City of North York Winter Maintenance Parking Prohibited) in § 950-1303, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Basil Hall Court	Beecroft Road and the south end of Basil Hall Court

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Basil Hall Court	Both	Beecroft Road and the south end of Basil Hall Court	Anytime

- C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Basil Hall Court	East	A point 30 metres north of the south end of Basil Hall Court and a point 30 metres further north	9:00 a.m. to 4:00 p.m. and 6:00 p.m. of one day to 7:30 a.m. of the next following day, inclusive
Basil Hall Court	East	A point 60 metres north of the south end of Basil Hall Court and Beecroft Road	Anytime

D. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Basil Hall Court	East	A point 30 metres north of the south end of Basil Hall Court and a point 30 metres further north	7:30 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.	15 mins.
