BY-LAW No. 516-2016

To amend City of Toronto Municipal Code Chapter 925, Permit Parking, respecting Arlington Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 925, Permit Parking, is amended as follows:

A. By deleting from Schedule A (Permit Parking), the following in alphabetical order by street name:

(From Column 1 Street)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Period)	(From Column 5 Time)
Arlington Avenue	Even	South limit to Vaughan Road	All times, no parking from 7:00 p.m. on the 1st day of each month to 7:00 p.m. on the 16th day of each month, April 1st to December 1st, inclusive	12:00 midnight to 6:00 a.m.
Arlington Avenue	Odd	South Limit to Vaughan Road	All times, except no parking from 7:00 p.m. on the 16th day of each month to 7:00 p.m. on the 1st day of each month, Apr. 1 to Dec. 1, inclusive and no parking anytime from 7:00 p.m. Dec. 1 of one year to 7:00 p.m. Apr. 1 of the next following year, inclusive	12:00 midnight to 6:00 a.m.

B. By inserting in Schedule A (Permit Parking), the following in alphabetical order by street name:

(In Column 1 Street)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Period)	(In Column 5 Time)
Arlington Avenue	Even	From a point 37.5 metres north of St. Clair Avenue West to Vaughan Road	All times, except no parking anytime from the 1st day of each month to 15th day of each month from Apr. 1 to Nov. 30 inclusive	12:00 midnight to 6:00 a.m.

Arlington Avenue	Odd	From a point 37.5 metres north of St. Clair Avenue West to Vaughan Road	All times, except no parking anytime from Dec. 1 of one year to Mar 31 of the next following year, inclusive and from the 16th day of each month to the last day of each month from Apr. 1 to Nov. 30, inclusive	12:00 midnight to 6:00 a.m.
