BY-LAW No. 517-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Arlington Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Arlington Avenue	Both	St. Clair Avenue West and a point 53.2 metres north of St. Clair Avenue West	Anytime
Arlington Avenue	East	A point 53.6 metres north of St. Clair Avenue West and Vaughan Road	Anytime, Dec. 1 to Mar. 31, inclusive
Arlington Avenue	East	A point 53.6 metres north of St. Clair Avenue West and Vaughan Road	From the 16th day of each month to the last day of each month, Apr. 1 to Nov. 30, inclusive
Arlington Avenue	West	A point 53.6 metres north of St. Clair Avenue West and Vaughan Road	From the 1st day of each month to the 15th day of each month, Apr. 1 to Nov. 30, inclusive

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Arlington Avenue	East	St. Clair Avenue West and a point 37.5 metres north	Anytime
