BY-LAW No. 599-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Redgrave Drive.

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Redgrave Drive	Both	A point 149.5 metres west of Martin Grove Road and a point 146 metres west thereof	8:00 a.m. to 5:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Redgrave Drive	North	A point 105 metres west of Martin Grove Road and a point 146 metres further west	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Redgrave Drive	South	A point 175 metres west of Martin Grove Road and a point 75 metres further west	8:00 a.m. to 5:00 p.m., Mon. to Fri.

- C. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Redgrave Drive	South	A point 105 metres west of Martin Grove Road and a point 70 metres further west	8:00 a.m. to 5:00 p.m., Mon. to Fri.	10 mins.

- D. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Redgrave Drive	South	A point 206 metres west of Martin Grove Road and a point 15 metres further west	8:00 a.m. to 5:00 p.m.
