BY-LAW No. 639-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Rosehill Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rosehill Avenue	South	A point 109.7 metres east of Yonge Street and a point 68.6 metres west of Avoca Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Rosehill Avenue	South	A point 209 metres east of Yonge Street and a point 68.6 metres west of Avoca Avenue	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Rosehill Avenue	Both	Yonge Street and a point approximately 50 metres east	Anytime

Rosehill Avenue	North	A point 44 metres east of Yonge Street and a point 11 metres further east	7:30 a.m. to 9:00 a.m., 3:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.
Rosehill Avenue	North	A point 113 metres east of Yonge Street and a point 17 metres further east	7:30 a.m. to 9:00 a.m., 3:00 p.m. to 6:00 p.m., Mon. to Fri.	10 mins.

G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

Rosehill Avenue	North	A point 58 metres east of Yonge Street and Avoca Avenue	Anytime
Rosehill Avenue	South	A point approximately 50 metres east of Yonge Street and a point 109.7 metres east of Yonge Street	Anytime

H. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

Rosehill Avenue	North	A point 44 metres east of Yonge Street and a point 11 metres further east	9:00 a.m. to 3:00 p.m. and 6:00 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.
Rosehill Avenue	North	A point 55 metres east of Yonge Street and a point 58 metres further east	Anytime
Rosehill Avenue	North	A point 113 metres east of Yonge Street and a point 17 metres further east	9:00 a.m. to 3:00 p.m. and 6:00 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun.
Rosehill Avenue	North	A point 130 metres east of Yonge Street and Avoca Avenue	Anytime
