BY-LAW No. 650-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Bellair Street and Cumberland Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Times and/or Days)
Bellair Street	East	Between a point 15 metres north of Bloor Street West and Cumberland Street	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Cumberland Street	North	Between a point 169 metres east of Avenue Road and a point 9 metres west of Bellair Street	6:00 a.m. to 4:00 p.m., Mon. to Fri.

B. By inserting in Schedule VI (Commercial Loading Zones) in § 950-1305, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Bellair Street	East	Between a point 15 metres north of Bloor Street West and Mayfair Mews	6:00 a.m. to 6:00 p.m., Mon. to Fri.
Cumberland Street	North	Between a point 169 metres east of Avenue Road and a point 20 metres west of Bellair Street	6:00 a.m. to 4:00 p.m., Mon. to Fri.

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Cumberland Street	North	Bellair Street and a point 9 metres west	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Bellair Street	East	Mayfair Mews and Cumberland Street	Anytime
Cumberland Street	North	Bellair Street and a point 20 metres west	Anytime

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Bellair Street	East	A point 15 metres north of Bloor Street West and Cumberland Street	6:00 p.m. of one day to 6:00 a.m. of the next following day, Mon. to Fri.; and anytime Sat., Sun and public holidays

F. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Bellair Street	East	A point 15 metres north of Bloor Street West and Mayfair Mews	6:00 p.m. of one day to 6:00 a.m. of the next following day, Mon. to Fri.; and anytime Sat., Sun and public holidays
