CITY OF TORONTO

BY-LAW No. 797-2016

To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Blackthorn Avenue, Donald Avenue, Litchfield Court, Norman Avenue, Osler, Street, Perth Avenue, Silverthorn Avenue and Windermere Avenue.

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| (From Column 1 Highway) | (From Column 2 Side) | (From Column 3 Between) | (From Column 4 Time or Days) |
|-------------------------|----------------------|---|------------------------------|
| Blackthorn Avenue | West | A point 96.5 metres south of Rowntree Avenue and a point 5.5 metres further south | Anytime |
| Norman Avenue | South | A point 55 metres west of Caledonia Road and a point 5.5 metres further west | Anytime |
| Osler Street | East | A point 40 metres north of the curb line of Lindner Street and a point 5.5 metres further north | Anytime |
| Perth Avenue | East | A point 28.5 metres south of Davenport Road and a point 5.5 metres further south | Anytime |
| Perth Avenue | West | A point 30 metres south of Davenport Road and a point 5.5 metres further south | Anytime |
| Windermere Avenue | East | A point 132.7 metres north of Colbeck Street and a point 5.5 metres further north | Anytime |

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

| (In Column 1 Highway) | (In Column 2 Side) | (In Column 3 Between) | (In Column 4 Time or Days) |
|-----------------------------|--------------------------|--|----------------------------------|
| Donald Avenue | South | A point 59.7 metres west of Kane Avenue and a point 5.5 metres further west | Anytime |
| Litchfield Court | North | A point 103.3 metres east of Silverstone Drive and a point 5.5 metres further east | Anytime |
| Silverthorn Avenue | West | A point 69.5 metres north of Rowntree Avenue and a point 5.5 metres further north | Anytime |
| Windermere Avenue | East | A point 148 metres north of Colbeck Street and a point 5.5 metres further north | Anytime |
