BY-LAW No. 826-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting St. Joseph Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
St. Joseph Street	North	Queen's Park Crescent East and a point 61.6 metres west of Bay Street	Anytime, Mon. to Fri.
St. Joseph Street	South	Queen's Park Crescent East and a point 61.6 metres west of Bay Street	Anytime, Mon. to Sat.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
St. Joseph Street	North	Queen's Park Crescent East and Bay Street	Anytime, Mon. to Fri.
St. Joseph Street	South	Queen's Park Crescent East and Bay Street	Anytime, Mon. to Sat.

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Time and/or Days)
St. Joseph Street	Both	Bay Street and a point 61.6 metres west	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
St. Joseph Street	North	Queen's Park Crescent East and a point 61.6 metres west of Bay Street	Anytime, Sat. and Sun.	2 hours
St. Joseph Street	South	Queen's Park Crescent East and a point 61.6 metres west of Bay Street	Anytime, Sun.	2 hours

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
St. Joseph Street	North	Queen's Park Crescent East and Bay Street	Anytime, Sat. and Sun.	2 hours
St. Joseph Street	South	Queen's Park Crescent East and Bay Street	Anytime, Sun.	2 hours
