**CITY OF TORONTO**

**BY-LAW No. 839-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Augusta Avenue, Cameron Street, Paul Lane Gardens and Vanauley Street.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Paul Lane Gardens	South	A point 15 metres east of Augusta Avenue and a point 40 metres further east	Anytime
Paul Lane Gardens	South	A point 110 metres east of Augusta Avenue and a point 50 metres further east	Anytime

B. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Vanauley Street	East	Queen Street West and the north end of Vanauley Street	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Paul Lane Gardens	Both	A point 55 metres east of Augusta Avenue and a point 55 metres further east	Anytime
Paul Lane Gardens	Both	A point 160 metres east of Augusta Avenue and a point 17 metres further east	Anytime
Paul Lane Gardens	Both	Augusta Avenue and a point 15 metres east	Anytime
Vanauley Street	Both	Paul Lane Gardens and a point 15 metres south	Anytime

D. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Vanauley Street	East	Queen Street West and a point 170 metres north	Anytime
Vanauley Street	West	A point 58.5 metres north of Queen Street West and a point 12.5 metres further north	Anytime

E. By inserting in Schedule XXVII (Compulsory Stops) in § 950-1326, the following in alphabetical order by street name:

(In Column 1 Intersection)	(In Column 2 Stop Street or Highway)
Paul Lane Gardens and Augusta Avenue	Paul Lane Gardens (westbound)
Paul Lane Gardens and Cameron Street	Paul Lane Gardens (eastbound)
