BY-LAW No. 850-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Front Street West and York Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
York Street	East	Between a point 18.5 metres north of Front Street West and a point 20.1 metres further north	Anytime

B. By inserting in Schedule X (Bus Loading Zones) in § 950-1309, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
York Street	East	Between a point 38.6 metres north of Front Street West and a point 15 metres further north	Anytime

C. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Front Street West	North	York Street and University Avenue	Anytime
York Street	East	Front Street West and a point 36 metres north of Wellington Street West	Anytime

D. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
York Street	East	Piper Lane and a point 36 metres north of Wellington Street West	Anytime

E. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Front Street West	Both	York Street and Simcoe Street	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays
York Street	Both	Front Street West and a point 30.5 metres south of Richmond Street West	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays

F. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Front Street West	North	University Avenue (west leg) and University Avenue (east leg)	Anytime
York Street	East	A point 14.5 metres south of Piper Lane and a point 30.5 metres south of Richmond Street West	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays
York Street	West	Front Street West and a point 30.5 metres south of Richmond Street West	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri., except public holidays

G. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Front Street West	North	Blue Jays Way and University Avenue	6:30 p.m. to 12:00 midnight, Mon. to Fri.; 12:00 noon to 6:00 p.m., on Sat., Sun. and public holidays; Apr. 1 to Nov. 30 of the same year, inclusive

H. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Front Street West	North	Blue Jays Way and University Avenue (west leg)	6:30 p.m. to 12:00 a.m., Mon. to Fri. and 12:00 p.m. to 6:00 p.m., on Sat., Sun. and public holidays from Apr. 1 to Nov. 30, inclusive
York Street	East	Front Street West and Piper Lane	Anytime
