BY-LAW No. 857-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the naming of a public lane as "Al Green Lane".

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Lane, first east of Yonge Street	Both	Merton Street and Balliol Street	Anytime

B. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Al Green Lane	Both	Merton Street and Balliol Street	Anytime

C. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Lane first east of Yonge Street	Balliol Street and Merton Street	Anytime	Southbound

D. By inserting in Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Times and/or Days)	(In Column 4 Direction)
Al Green Lane	Merton Street and Balliol Street	Anytime	Southbound

E. By deleting from Schedule XLI (Speed Control Zones – Public Laneways) in § 950-1340, the following in alphabetical order by street name:

Column 1
Highways or Lanes)

Lane first east of Yonge Street, between Merton Street and Balliol Street, as shown in Drawing No. 421F-2935.

F. By inserting in Schedule XLI (Speed Control Zones – Public Laneways) in § 950-1340, the following in alphabetical order by street name:

Al Green Lane, between Merton Street and Balliol Street, as shown in Drawing No. 421F-2935
