BY-LAW No. 859-2016

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting
Grenville Street, Grosvenor Street and Surrey Place.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Grosvenor Street	South	Bay Street and Yonge Street	Anytime
