**CITY OF TORONTO**

**BY-LAW No. 908-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Finch Avenue East and Finch Avenue West.**

Whereas City of Toronto Council, at its meeting of November 6, 7 and 8, 2001, adopted without amendment Works Committee Report No. 16, Clause No. 4, entitled "Speed Limit on Finch Avenue East Between Bayview Avenue and Don Mills Road (Ward 24 – Willowdale, Ward 33 – Don Valley East)" and, in so doing, approved an increase in the speed limit from 50 to 60 kilometres per hour on Finch Avenue East, between Bayview Avenue and Don Mills Road; and

Whereas City of Toronto Council enacted By-law No. 957-2001 on November 8, 2001, in connection with the above-noted Clause; and

Whereas, due to an administrative error/oversight, former Metropolitan By-law No. 109-86 to prescribe maximum rates of speed on certain [former] Metropolitan Roads was not updated to include amendments enacted under the above-mentioned By-law No. 957-2001; and

Whereas a result of the above, the amendments enacted under By-law No. 957-2001 were not brought forward into Municipal Code Chapter 950, Traffic and Parking, when traffic and parking By-laws/Codes were consolidated under By-law No. 1409-2011, enacted by City Council on December 1, 2011; and

Whereas the posted speed limit on Finch Avenue East, between Bayview Avenue and Don Mills Road, is currently 60 kilometres per hour; and

Whereas under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit km/h))
Finch Avenue	Islington Avenue and Bayview Avenue	60
Finch Avenue East	Don Mills Road and Markham Road	60

B. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit km/h))
Finch Avenue East	Yonge Street and Markham Road	60
Finch Avenue West	Islington Avenue and Yonge Street	60
