BY-LAW No. 924-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Kingston Road.

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Kingston Road	North and west	A point 78 metres east of Glen Manor Drive and Malvern Avenue	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Kingston Road	North and west	Queen Street East and a point 43.5 metres east of Glen Manor Drive	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Kingston Road	North and west	Queen Street East and a point 8 metres east of Glen Manor Drive	4:00 p.m. to 6:00 p.m., Mon. to Fri., except public holidays
Kingston Road	North	Malvern Avenue and a point 28.5 metres east	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

Kingston Road	North and west	Queen Street East and a point 81 metres east of Glen Manor Drive	7:00 a.m. to 9:00 a.m., Mon. to Fri., except public holidays
Kingston Road	North and west	A point 81 metres east Glen Manor Drive and a point 58 metres further east	7:00 a.m. to 10:00 a.m. and 2:00 p.m. to 5:00 p.m., Mon. to Fri.

E. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Kingston Road	North	A point 31 metres east of the east curb of Glen Manor Drive and a point 56 metres further east	7:00 a.m. to 6:00 p.m., Mon. to Fri.

F. By deleting from Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Times and/or Days)
Kingston Road	North	A point 31 metres east of a point opposite Glen Manor Drive and a point 56 metres further east	8:00 a.m. to 5:00 p.m.
Kingston Road	North	A point 43.5 metres east of a point opposite Glen Manor Drive and a point 34.5 metres further east	8:00 a.m. to 5:00 p.m.

G. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Kingston Road	North and west	A point 81 metres east of Glen Manor Drive and a point 58 metres further east	7:00 a.m. to 10:00 a.m. and 2:00 p.m. to 5:00 p.m., Mon. to Fri.
