BY-LAW No. 997-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Renforth Drive.

Whereas Etobicoke York Community Council, at its meeting of October 2, 2007, adopted Item EY10.20 entitled 'Renforth Drive, north of Highway 401– Speed Limit Amendment' and, in so doing, approved an amendment to the speed limit from 50 to 60 kilometres per hour on Renforth Drive, from a point 300 metres north of Eglinton Avenue West to a point 250 metres southwest of Silver Dart Drive; and

Whereas Etobicoke York Community Council enacted By-law No. 1090-2007 on October 2, 2007 in connection with the above-noted Item; and

Whereas By-law No. 1090-2007 mistakenly amended Schedule A to Article II (Forty-Kilometre Speed Limits) instead of Schedule A to Article III (Increased Speed Limits) of former City of Etobicoke Municipal Code Chapter 240 in connection with the above; and

Whereas the aforementioned error was carried forward into Schedule XXXV, Speed Limits on Public Highways, when traffic and parking by-laws of the various former area municipalities were consolidated under Municipal Code Chapter 950, Traffic and Parking, enacted under By-law No. 1409-2011 on December 1, 2011; and

Whereas the posted speed limit on Renforth Drive, between a point 300 metres north of Eglinton Avenue West and a point 250 metres south west of Silver Dart Drive, is currently 60 kilometres per hour; and

Whereas under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Speed Limit (km/h))
Renforth Drive	A point 300 metres north of Eglinton Avenue West and a point 250 metres southwest of Silver Dart Drive	40

B. By inserting in Schedule XXXV (Speed Limits on Public Highways) in § 950-1334, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Between)	(In Column 3 Speed Limit (km/h))
Renforth Drive	A point 300 metres north of Eglinton Avenue West and a point 250 metres south west of Silver Dart Drive	60
