**CITY OF TORONTO**

**BY-LAW No. 1013-2016**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Ashtonbee Road.**

The Scarborough Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Ashtonbee Road	North	Lebovic Avenue and Warden Avenue	Anytime
Ashtonbee Road	South	Lebovic Avenue and Warden Avenue	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ashtonbee Road	North	A point 654.5 metres east of Pharmacy Avenue and Warden Avenue	Anytime
Ashtonbee Road	South	Hakimi Avenue and Warden Avenue	Anytime

C. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Ashtonbee Road	North	A point 479.5 metres east of Pharmacy Avenue and a point 45 metres further east	Anytime
Ashtonbee Road	South	A point 466 metres east of Pharmacy Avenue and Lebovic Avenue	Anytime

D. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Ashtonbee Road	North	A point 479.5 metres east of Pharmacy Avenue and a point 175 metres further east	Anytime
Ashtonbee Road	South	A point 466 metres east of Pharmacy Avenue and Hakimi Avenue	Anytime
