**CITY OF TORONTO**

**BY-LAW No. 1024-2016**

**To amend City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Bellwoods Avenue, Concord Avenue, Crawford Street, Gatwick Avenue, Hill Crest Park, Milverton Boulevard, Prust Avenue, Ravina Crescent and Roseheath Avenue.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, is amended as follows:
  - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time or Days)
Concord Avenue	East	A point 98.6 metres south of Hepbourne Street and a point 5.5 metres further south	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive, and from the 1 <sup>st</sup> day to the 15 <sup>th</sup> day of each month from Apr. 1 to Nov. 30, inclusive
Concord Avenue	West	A point 101.6 metres south of Hepbourne Street and a point 5.5 metres further south	Anytime from the 16 <sup>th</sup> day to the last day of each month from Apr. 1 to Nov. 30 inclusive
Milverton Boulevard	South	A point 66.3 metres west of Linnsmore Crescent and a point 5.5 metres further west	Anytime
Roseheath Avenue	West	A point 41 metres south of Merrill Avenue West and a point 4 metres further south	Anytime

B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time or Days)
Bellwoods Avenue	East	A point 18.5 metres north of Treford Place and a point 5.5 metres further north	Anytime
Crawford Street	West	A point 78 metres north of Queen Street West and a point 5.4 metres further north	Anytime
Gatwick Avenue	South	A point 67 metres west of Chisholm Avenue and a point 5.5 metres further west	Anytime
Hill Crest Park	South	A point 76 metres south/east of Amelia Street and a point 5.5 metres further east	Anytime
Milverton Boulevard	South	A point 71 metres west of Linnsmore Crescent and a point 5.5 metres further west	Anytime
Prust Avenue	West	A point 120 metres north of Gerrard Street East and a point 5.5 metres further north	Anytime
Ravina Crescent	East	A point 14 metres south of a point opposite the south curb of Earl Grey Road and a point 5.5 metres further south	Anytime
