BY-LAW No. 1030-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Regent Street and Shuter Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Regent Street	West	A point 80 metres north of Shuter Street and a point 16.5 metres further north	9:00 a.m. to 11:30 a.m., 1:30 p.m. to 3:30 p.m., 4:30 p.m. of one day to 7:30 a.m. of the next following day, Mon. to Fri., Anytime, Sat. and Sun.
Shuter Street	North	A point 10.5 metres west of Regent Street and a point 23.5 metres further west	9:00 a.m. to 11:30 a.m., 1:30 p.m. to 3:30 p.m., Mon to Fri.

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Regent Street	West	Shuter Street and St. David Street	Anytime

C. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Regent Street (TO)	West	A point 80 metres north of Shuter Street and a point 16.5 metres further north	7:00 a.m. to 9:00 a.m., 11:30 a.m. to 1:30 p.m., 3:30 p.m. to 4:30 p.m., Mon to Fri.	15 mins.
Shuter Street	North	A point 10.5 metres west of Regent Street and a point 23.5 metres further west	7:00 a.m. to 9:00 a.m., 11:30 a.m. to 1:30 p.m., 3:30 p.m. to 4:30 p.m., Mon to Fri.	15 mins.

D. By deleting from Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Regent Street	West	Dundas Street East and a point opposite the north curb line of St. David Walk Street	Anytime

E. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Regent Street	West	St. David Street and Dundas Street East	Anytime
