BY-LAW No. 1082-2016

To amend City of Toronto Municipal Code Chapter 841, Waste Collection, Commercial Properties, Chapter 844, Waste Collection, Residential Properties, Chapter 846, Waste Transfer Stations, and Chapter 849, Water and Sewage Services and Utility Bill, to update certain terms.

Whereas City Council seeks to update certain terms used in the Toronto Municipal Code with respect to Solid Waste Management Services; and

Whereas City Council has authorized that Chapters 841, 844, 846 and 849 of the Code, among others, be amended to conform to such terms;

The Council of the City of Toronto enacts:

1. Chapter 841, Waste Collection, Commercial Properties, is amended as follows:
 - A. In section 841-1, "MIXED RESIDENTIAL/COMMERCIAL" is deleted and replaced with "RESIDENTIAL UNITS ABOVE COMMERCIAL or RUAC". The word "PROPERTIES" and the definition remain unchanged.
 - B. Throughout the remainder of Chapter 841:
 1. The term "mixed residential/commercial" is deleted and replaced with the term "RUAC";
 2. The term "source separated organics" is deleted and replaced with the term "organic materials";
 3. The term "bulky item" is deleted and replaced with the term "oversized item";
 4. The term "bin" is deleted and replaced with the term "cart"; and
 5. The words "or white goods" are deleted.
2. Chapter 844, Waste Collection, Residential Properties, is amended throughout the chapter as follows:
 - A. The term "household residence" is deleted and replaced with the term "single family residential property";
 - B. The term "multiple household residence" is deleted and replaced with the term "multi-residential property";

- C. The term "residential front-end collection" is deleted and replaced with the term "multi-residential front-end collection";
 - D. The term "subscription property" is deleted and replaced with the term "multi-residential curbside property";
 - E. The term "leaf and yard waste" is deleted and replaced with the term "yard waste";
 - F. The term "bulky item" is deleted and replaced with the term "oversized item";
 - G. The term "white or metal goods" is deleted and replaced with the term "metal goods"; and
 - H. The term "in-suite recycling containers" is deleted and replaced with the term "in-unit recycling containers".
3. Chapter 846, Waste Transfer Stations, is amended in the title and throughout the chapter as follows:
- A. The term "Waste Transfer Station" is deleted and replaced with the term "Waste Management Facility".
4. Chapter 849, Waste Collection, Water and Sewage Services and Utility Bill, is amended throughout the chapter as follows:
- A. The term "multiple household residence" is deleted and replaced with the term "multi-residential property".
5. For each of the terminology replacements indicated above, anything in the singular shall be replaced in the singular and anything in the plural shall be replaced in the plural.
