BY-LAW No. 1163-2016

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Foxbar Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Foxbar Road	East and south	Avenue Road and St. Clair Avenue West	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Foxbar Road	East	St. Clair Avenue West and a point 67 metres south	Anytime

C. By deleting from Schedule XVIII (One-Way Highways) in § 950-1317, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)	(From Column 3 Times and/or Days)	(From Column 4 Direction)
Foxbar Road	Avenue Road and a point 68.6 metres south of St. Clair Avenue West	Anytime	Southbound and westbound

D By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Foxbar Road	East and South	Avenue Road and a point 67 metres south of St. Clair Avenue West	Anytime

E. By inserting in Schedule XXV (Entry Prohibited) in § 950-1324, the following in alphabetical order by street name:

(In Column 1 Highway Not To Be Entered)	(In Column 2 From)	(In Column 4 Prohibited Times and/or Days)
Foxbar Road north of a point 85 metres south of St. Clair Avenue West	Foxbar Road south of a point 85 metres south of St. Clair Avenue West	Anytime (emergency vehicles and bicycles excepted)
Foxbar Road south of a point 85 metres south of St. Clair Avenue West	Foxbar Road north of a point 85 metres south of St. Clair Avenue West	Anytime (emergency vehicles and bicycles excepted)
