## **CITY OF TORONTO**

### **BY-LAW No. 1241-2016**

#### **To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Mortimer Avenue.**

Whereas former Borough of East York Uniform Traffic By-law No. 92-93, Schedule VIII, No Parking, contained an entry prohibiting parking on the north side of Mortimer Avenue, between Broadview Avenue and Pape Avenue, from 4:00 p.m. to 6:00 p.m. Monday to Friday; and

Whereas former Borough of East York Uniform Traffic By-law No. 92-93, Schedule VIII, No Parking, contained entries prohibiting parking anytime on the south side of Mortimer Avenue, between Woodbine Avenue and Woodmount Avenue and between Binswood Avenue and Knight Street; and

Whereas traffic and parking By-laws of the various former area municipalities were consolidated under Municipal Code Chapter 950, Traffic and Parking, enacted under By-law No. 1409-2011 on December 1, 2011; and

Whereas the above-mentioned parking prohibition hours on the north side of Mortimer Avenue, between Broadview Avenue and Pape Avenue, were mistakenly changed to "Anytime" when traffic and parking By-laws were consolidated under By-law No. 1409-2011; and

Whereas the above-mentioned parking prohibitions in effect at anytime on the south side of Mortimer Avenue were mistakenly shown as being in effect between "Woodbine Avenue and Knight Street" when traffic and parking By-laws were consolidated under By-law No. 1409-2011; and

Whereas regulatory signage is currently posted indicating that parking is prohibited from 4:00 p.m. to 6:00 p.m. Monday to Friday on the north side of Mortimer Avenue, between Broadview Avenue and Pape Avenue; and

Whereas regulatory signage is currently posted indicating that parking is prohibited anytime on the south side of Mortimer Avenue, between Woodbine Avenue and Woodmount Avenue and between Binswood Avenue and Knight Street; and

Whereas Council authorized in Works Committee Report 6, Clause 4, that the consolidation of all of the Traffic and Parking-related Schedules as updated by the text editor be authorized, without verification, and provided that any duplications or errors which are discovered during the consolidation process or in future for any of the entries in those Schedules may be corrected by way of introducing a Bill as a technical amendment; and

Whereas under Section 169-26 of Chapter 169, Officials, City, of The City of Toronto Municipal Code, the City Solicitor, in consultation with the City Clerk, may submit bills directly to make technical amendments to The City of Toronto Municipal Code and other by-laws to correct technical errors;

The Council of the City of Toronto enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

|-----------------------------|--------------------------|---|---|
| Mortimer Avenue             | North                    | Broadview Avenue and Pape Avenue        | 4:00 p.m. to 6:00 p.m.,<br>Mon. to Fri.             |
| Mortimer Avenue             | South                    | Binswood Avenue and Knight Street       | Anytime   |
| Mortimer Avenue             | South                    | Woodbine Avenue and<br>Woodmount Avenue | Anytime   |
