## CITY OF TORONTO

### BY-LAW 807-2017

**To amend City of Toronto Municipal Code Chapter 915, Parking on Private or Municipal Property, to remove stopping, standing and parking offences from the Provincial Offences Act and place them under the Administrative Penalty System for Parking Violations and associated amendments.**

The Council of the City of Toronto enacts:

1. Chapter 915, Parking on Private or Municipal Property, of the City of Toronto Municipal Code is amended by:
  - A. Inserting in Section 915-1 in alphabetical order a new definition for "Administrative Penalty", "Penalty Notice" and "Vehicle Owner" as follows:

ADMINISTRATIVE PENALTY – as defined in Chapter 610, Penalties, Administration of.

PENALTY NOTICE – as defined in Chapter 610, Penalties, Administration of.

VEHICLE OWNER – as defined in Chapter 610, Penalties, Administration of.
  - B. Deleting Subsection B from the definition of "Designated Event" in Section 915-1 and inserting a new Subsection B as follows:
    - B. The service of a penalty notice in accordance with the provisions of Chapter 610, Penalties, Administration of, if the removal of the vehicle is authorized by a municipal law enforcement officer not employed by the Toronto Police Service.
  - C. Deleting Subsection C of Section 915-4 and inserting a new Subsection C as follows:
    - C. If the vehicle bears a number plate issued under the *Highway Traffic Act*, as amended, a penalty notice is issued and served in accordance with the provisions of Chapter 610, Penalties, Administration of.
  - D. Deleting Subsection B from Section 915-5 and inserting a new Subsection B as follows:
    - B. A penalty notice is issued and served in accordance with the provisions of Chapter 610, Penalties, Administration of.

- E. Inserting the phrase: "or is liable to an administrative penalty" after the word "offence" in Subsection 915-7A.
  - F. Deleting Subsections B and C from Section 915-7 and inserting new Subsections B and C as follows:
    - B. Unless at the time of the contravention the vehicle was in the possession of another person without the vehicle owner's consent, if a vehicle has been left parked, standing or stopped in contravention of § 915-2A or § 915-2B, the vehicle owner shall, upon issuance of a penalty notice, be liable to an administrative penalty.
    - C. Every person convicted of an offence under this chapter, other than an administrative penalty under §§ 915-2A or 915-2B, is liable to a fine as provided for in the *Provincial Offences Act*.
2. This by-law shall come into effect on August 28, 2017.
