BY-LAW 374-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Dean Park Road.

The Scarborough Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Dean Park Road	North	Red River Crescent (west intersection) and a point 75 metres west	7:00 a.m. to 6:00 p.m., Mon. to Fri.
Dean Park Road	South	A point 33 metres east of Red River Crescent (east intersection) and a point 160 metres further west	7:00 a.m. to 6:00 p.m., Mon. to Fri.

B. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Dean Park Road	North	Braymore Boulevard and a point 75 metres west of Red River Crescent (west intersection)	8:00 a.m. to 4:00 p.m., Mon. to Fri.
Dean Park Road	South	Red River Crescent (east intersection) and a point 160 metres east of Sudbury Hall Drive (east intersection)	8:00 a.m. to 5:00 p.m., Mon. to Fri.
Dean Park Road	South	A point 30 metres east of Sudbury Hall Drive (east intersection) and a point 67 metres further east	Anytime

C. By inserting in Schedule XXV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Dean Park Road	South	A point 97 metres east of Sudbury Hall Drive (east intersection) and a point 63 metres further east	8:00 a.m. to 4:00 p.m., Mon. to Fri.	30 mins.
Dean Park Road	South	Red River Crescent (east intersection) and Braymore Boulevard	8:00 a.m. to 4:00 p.m., Mon. to Fri.	30 mins.

D. By inserting in Schedule XXXVII (School Bus Loading Zones) in § 950-1336, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Times and/or Days)
Dean Park Road	South	A point 160 metres east of Sudbury Hall Drive (east intersection) and Red River Crescent (east intersection)	8:00 a.m. to 5:00 p.m. Mon. to Fri.
