BY-LAW 447-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Castle View Avenue, Russell Hill Drive and Walmer Road.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Castle View Avenue	North	Walmer Road and Spadina Road	Each Thu., Apr. 1 to Nov. 30, inclusive
Castle View Avenue	South	Walmer Road and Spadina Road	Anytime, except each Thu., Apr. 1 to Nov. 30, inclusive
Russell Hill Drive	North	A point 60 metres west of Spadina Road and Walmer Road	Anytime
Russell Hill Drive	North	Spadina Road and a point 60 metres further west	Anytime, except Thu., Apr. 1 to Nov. 30, inclusive
Russell Hill Drive	South	A point 60 metres west of Spadina Road and Walmer Road	Anytime
Russell Hill Drive	South	Spadina Road and a point 60 metres further west	Each Thu., Apr. 1 to Nov. 30, inclusive
Walmer Road	East	Austin Terrace and Russell Hill Drive	Anytime, except Thu. Apr. 1 to Nov. 30, inclusive
Walmer Road	West	Austin Terrace and Russell Hill Drive	Each Thu., Apr. 1 to Nov. 30, inclusive
Walmer Road	West	Russell Hill Drive and the north end of Walmer Road	Anytime
