**CITY OF TORONTO**

**BY-LAW 673-2018**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Lou Pomanti Street and Mary Chapman Boulevard.**

The Etobicoke York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
  - A. By deleting from Schedule IV (Former City of North York Winter Maintenance Parking Prohibited) in § 950-1303, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Between)
Lou Pomanti Street	Mary Chapman Boulevard and Isaac Devins Boulevard

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mary Chapman Boulevard	East	A point 20 metres south of Lou Pomanti Street and Sheppard Avenue West	Anytime

- C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Lou Pomanti Street	North	Mary Chapman Boulevard and Isaac Devins Boulevard	Anytime
Mary Chapman Boulevard	East	Isaac Devins Boulevard (south intersection) and Sheppard Avenue West	Anytime

D. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 3 Time and/or Days)	(From Column 4 Maximum Period Permitted)
Mary Chapman Boulevard	West	A point 20 metres south of Lou Pomanti Street and Parrotta Drive	8:00 p.m. to 8:00 a.m.	12 hours

E. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 3 Time and/or Days)	(In Column 4 Maximum Period Permitted)
Lou Pomanti Street	South	Mary Chapman Boulevard and Isaac Devins Boulevard	8:00 p.m. of one day to 8:00 a.m. of the next following day	12 hours
Mary Chapman Boulevard	West	Isaac Devins Boulevard (south intersection) and Parrotta Drive	8:00 p.m. of one day to 8:00 a.m. of the next following day	12 hours
