## CITY OF TORONTO

### BY-LAW 681-2018

#### To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting the renaming of a portion of Thorncliffe Park Drive west of Beth Neilson Drive as Pat Moore Drive.

The North York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Beth Neilson Drive	Both	Thorncliffe Park Drive and Wicksteed Avenue	Anytime
Thorncliffe Park Drive	Both	Beth Neilson Drive and the west limit of the east leg of Thorncliffe Park Drive	Anytime
Thorncliffe Park Drive	West	Overlea Boulevard (east intersection) and Beth Neilson Drive	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Beth Neilson Drive	Both	Thorncliffe Park Drive/Pat Moore Drive and Wicksteed Avenue	Anytime
Thorncliffe Park Drive	Both	Beth Neilson Drive/Pat Moore Drive and the west limit of the east leg of Thorncliffe Park Drive	Anytime
