BY-LAW 722-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Brownlow Avenue.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:
 - A. By inserting in Schedule VII (Passenger Loading Zones) in § 950-1306, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Location)	(In Column 4 Times and/or Days)
Brownlow Avenue	East	A point 51 metres south of Eglinton Avenue East and a point 24 metres further south	7:00 a.m. to 6:00 p.m., Mon. to Fri.

- B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Brownlow Avenue	East	A point 16.6 metres south of Eglinton Avenue East and a point 58.4 metres further south	6:00 p.m. of one day to 7:00 a.m. of the next following day, Mon. to Fri.; Anytime, Sat. and Sun.

- C. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

Brownlow Avenue	East	A point 75 metres south of Eglinton Avenue East and a point 40 metres further south	Anytime
Brownlow Avenue	East	Soudan Avenue and a point 173 metres south of Eglinton Avenue East	Anytime

- F. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Brownlow Avenue	East	A point 16.6 metres south of Eglinton Avenue East and a point 58.4 metres further south	7:00 a.m. to 6:00 p.m., Mon. to Fri.	10 mins.

G. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

Brownlow Avenue	East	A point 16.6 metres south of Eglinton Avenue East and a point 34.4 metres further south	7:00 a.m. to 6:00 p.m., Mon. to Fri.	10 mins.

H. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Brownlow Avenue	East	A point 51 metres south of Eglinton Avenue East and a point 24 metres further south	7:00 a.m. to 6:00 p.m., Mon. to Fri.
Brownlow Avenue	East	A point 115 metres south of Eglinton Avenue East and a point 58 metres further south	Anytime
