CITY OF TORONTO

BY-LAW 900-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Village Green Square.

The Scarborough Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Village Green Square	Both	Kennedy Road and the east end of Village Green Square	Anytime

B. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Village Green Square	South	A point 348 metres east of Kennedy Road and a point 375.5 metres east of Kennedy Road	Anytime

C. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Village Green Square (east leg)	Both	Village Green Square (south leg) and a point 15 metres north	Anytime
