**CITY OF TORONTO**

**BY-LAW 932-2018**

**To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Madison Avenue.**

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By inserting in Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Madison Avenue	East	A point 96.5 metres north of Bloor Street West and a point 28.5 metres further north	10:00 a.m. to 3:00 p.m. and 5:00 p.m. to 9:00 p.m., Mon. to Fri.; Anytime Sat. and Sun.

B. By deleting from Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Time and/or Days)	(From Column 5 Maximum Period Permitted)
Madison Avenue	East	Bloor Street West and Lowther Avenue	7:00 a.m. to 6:00 p.m., Mon. to Sat.	1 hour

- C. By inserting in Schedule XV (Parking for Restricted Periods) in § 950-1314, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Time and/or Days)	(In Column 5 Maximum Period Permitted)
Madison Avenue	East	A point 96.5 metres north of Bloor Street West and a point 28.5 metres further north	8:00 a.m. to 10:00 a.m. and 3:00 p.m. to 5:00 p.m., Mon. to Fri.	10 mins.

- D. By inserting in Schedule XVI (No Standing) in § 950-1315, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Madison Avenue	East	A point 96.5 metres north of Bloor street West and a point 28.5 metres further north	7:00 a.m. to 8:00 a.m., Mon. to Fri.
