BY-LAW 985-2018

To amend City of Toronto Municipal Code Chapter 950, Traffic and Parking, respecting Mercer Street.

The Toronto and East York Community Council enacts:

1. Municipal Code Chapter 950, Traffic and Parking, is amended as follows:

A. By deleting from Schedule V (Stands for Taxicabs) in § 950-1304, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Location)	(From Column 4 Number of Taxicabs)	(From Column 5 Times and/or Days)
Mercer Street	South	Between a point 105 metres east of Blue Jays Way and a point 6 metres further east	1	Anytime

B. By deleting from Schedule XIII (No Parking) in § 950-1312, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mercer Street	North	A point 89.5 metres east of Blue Jays Way and a point 53.6 metres west of John Street	Anytime

C. By inserting in Schedule XIV (No Stopping) in § 950-1313, the following in alphabetical order by street name:

(In Column 1 Highway)	(In Column 2 Side)	(In Column 3 Between)	(In Column 4 Prohibited Times and/or Days)
Mercer Street	North	A point 104.6 metres east of Blue Jays Way and a point 53.6 metres west of John Street	Anytime
Mercer Street	South	A point 53.6 metres west of John Street and a point 75.5 metres east of Blue Jays Way	Anytime

D. By deleting from Schedule XIV (No Standing) in § 950-1315, the following in alphabetical order by street name:

(From Column 1 Highway)	(From Column 2 Side)	(From Column 3 Between)	(From Column 4 Prohibited Times and/or Days)
Mercer Street	North	A point 104.6 metres east of Peter Street/Blue Jays Way and John Street	6:30 p.m. to 12:00 a.m., Mon. to Fri. and 12:00 p.m. to 6:00 p.m. on Sat., Sun. and public holidays, from Apr. 1 to Nov. 30 of the same year, inclusive

2. This By-law shall be effective commencing July 20, 2018.
