**CITY OF TORONTO**

**BY-LAW 1036-2018**

**To authorize the naming of an unassumed street between Rean Drive and Barberry Place as Karen's Way.**

Whereas pursuant to Section 27-152E(5) of City of Toronto Municipal Code Chapter 27, Council Procedures, North York Community Council has the authority to pass a by-law naming the un-assumed street;

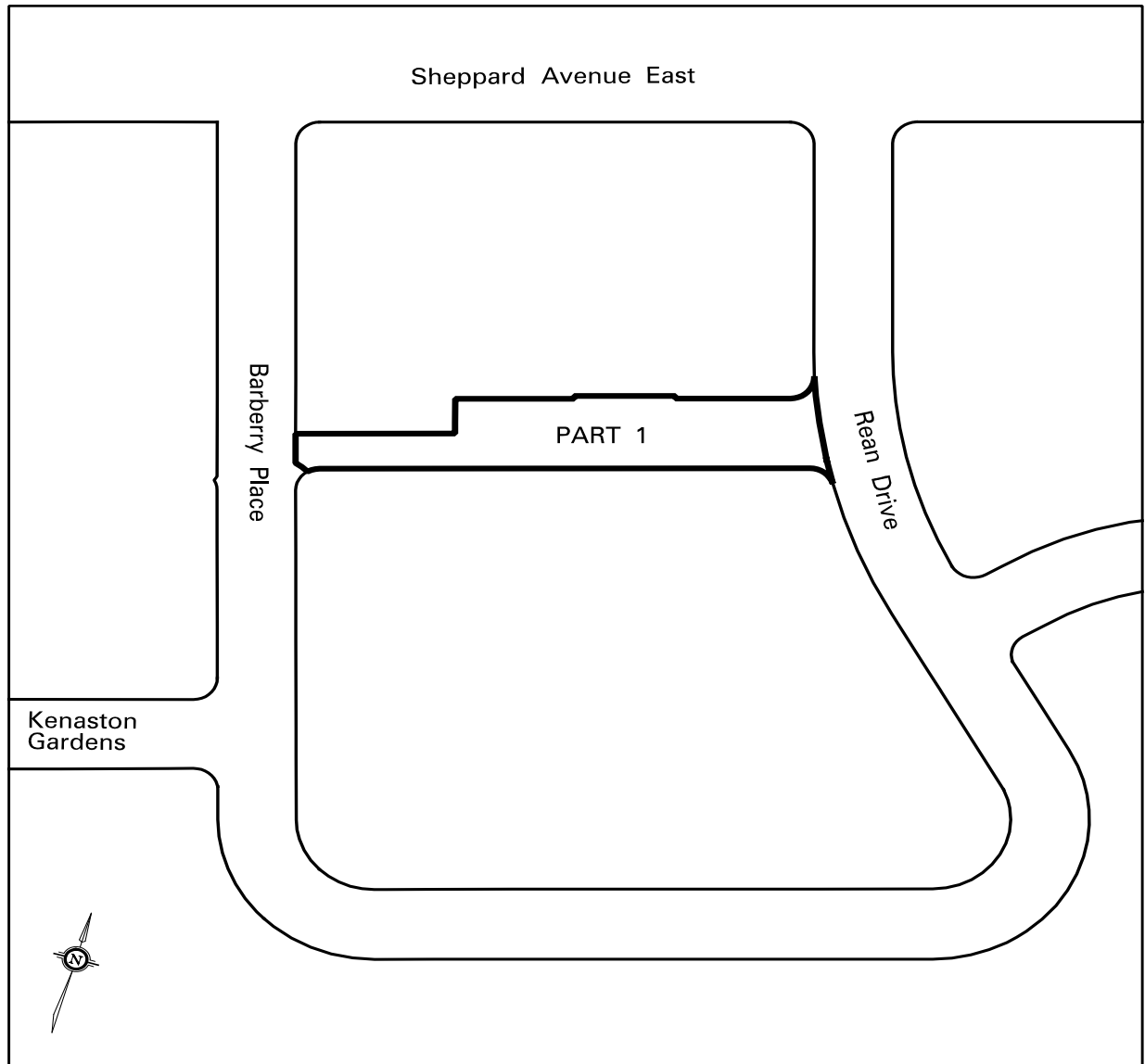
