CITY OF TORONTO

BY-LAW 1206-2018

To amend various chapters of the City of Toronto Municipal Code to update references to the Deputy City Manager and Chief Financial Officer.

Whereas at its meeting of October 2, 3 and 4, 2017, City Council realigned the Deputy City Manager and Chief Financial Officer position by separating it into two positions, namely the Chief Financial Officer and the Deputy City Manager, Internal Corporate Services; and

Whereas various chapters of the City of Toronto's Municipal Code still reference the single position of Deputy City Manager and Chief Financial Officer; and

Whereas it is necessary to update such Municipal Code references to the Deputy Manager and Chief Financial Officer, and to amend the Municipal Code to make such amendments;

The Council of the City of Toronto enacts:

- 1. The following chapters of the City of Toronto Municipal Code are amended as follows by replacing "Deputy City Manager and Chief Financial Officer" with Chief Financial Officer:
 - (1) the definition of Chief Financial Officer in:

 - (b) § 27-1 of Chapter 27, Council Procedures;
 - (c) § 30-1 of Chapter 30, Debentures and Other Borrowing;

 - (e) § 112-1.1 of Chapter 112, Investment Board;
 - (f) § 150-1 of Chapter 150, Municipal Law Enforcement Officers;
 - (g) § 227-1 of Chapter 227, Reserves and Reserve Funds;
 - (h) § 257-1 of Chapter 257, Signing Authority; and
 - (i) § 743-1 of Chapter 743, Street and Sidewalks, Use of.
 - (2) the definition of Chief Financial Officer in:
 - (a) § 63-1 of Chapter 53, Exhibition Place, Governance;
 - (b) § 849-26 of Chapter 849, Water and Sewage Services and Utility Bill; and
 - (c) § 851-1 of Chapter 851, Water Supply.
 - (3) Subsection 3-10.E of Chapter 3, Accountability Officers.
 - (4) Subsection 30-9.A of Chapter 30, Debentures and Other Borrowing.
 - (5) Subsection 103-13A and § 103-13F of Chapter 103, Heritage.
 - (6) Subsection 140-1B(1) of Chapter 140, Lobbying.
